FastStart 7–Level Bonuses

If you want to immediately earn all seven levels of FastStart Way Bonuses (\$100, \$25, \$20, \$20, \$20, \$20, \$20 paid weekly on your Downline Marketer's FastStart Way purchases), join The Trump Network The FastStart Way.

THE NEW FASTSTART WAY Q&As

Q: How soon can I receive all of the FastStart 7-Level Bonuses?

A: They're paid weekly and can start right away.

- The weekly checks are based upon all FastStart Way purchases from Sunday morning at 12:00 a.m. CST to Saturday night at 11:59 p.m. CST. All FastStart 7-Level Bonus checks are paid the following week.
- Qualified Marketers in a current week will get paid FastStart Bonuses for that same week.

Ex: A new FastStart Way Marketer enrolls Monday morning in your downline. Simply be qualified that same week to receive your FastStart bonus check which will be sent the following week.

Q: When do the FastStart 7-Level Bonuses begin?

A: All FastStart Bonuses begin August 12th.

- Due to the programming involved, bonuses earned between August 12th – August 31st will be tracked and considered as "week one." The August FastStart Bonuses will be paid September 20th.
- September purchases will be tracked and paid weekly.

Q: What if I already started the FastStart Way before August?

- A:**
- All Marketers who purchased the FastStart Way any time prior to August 12th are recognized as QuickSilver Directors (or above) for August, September and October, and are eligible to receive the FastStart 7-Level Bonuses.
 - Simply have an active Communication Program and active AutoShip 100 CV (or more) shipped anytime in August, subscribe to the Communication Program now and for each month thereafter. If you haven't already, you can choose to enroll for \$19.⁹⁵, first month is FREE.
 - You will now receive FastStart 7-Level Bonuses on all downline FastStart Way purchases in August. (Retroactive to August 12th.)

Q: If I choose not to join The FastStart Way, will I receive FastStart 7-Level Bonuses in month one?

A: No. You'll only receive the \$100 FastStart 1-Level Bonuses as an Enroller on your personally enrolled Marketers who choose the FastStart Way. All other FastStart 7-Level Bonuses roll-up, and are paid to upline qualified Marketers.

Q: Do FastStart 7-Level bonuses roll up from the Enroller or the Sponsor?

A: FastStart 7-Level are paid up the Enroller tree. The Enroller and the Sponsor may or may not be the same person. The Enroller has the ability to have the new Marketer be sponsored by someone in his or her downline. But this does not effect how the FastStart 7-Level Bonuses are paid.

Ex: Bob enrolls Mary the FastStart Way. He has Tom, who is on Bob's third level, sponsor her. Bob receives the FastStart 1st-Level Bonus of \$100 for Enrolling Mary and the other six (6) Level Bonuses are distributed to Bob's qualified upline Marketers. Then Mary enrolls Sue the FastStart Way. Mary receives the FastStart 1st-Level Bonus of \$100 for Enrolling Sue. The other six (6) Level Bonuses are distributed to Bob and his qualified upline Marketers. Tom as the Sponsor and anyone between him and Bob, do not participate in the FastStart 7-Level Bonuses initiated by Mary's enrollment.

Q: How does a Marketer receive the \$100 FastStart 1-Level Bonus?

A: If a Marketer does not start out the FastStart Way, it is understood that they must be on AutoShip, have 100 CV in their name, and subscribe to the Communication Program in order to qualify to receive the \$100 FastStart Bonus on their personally enrolled Marketers who choose the FastStart Way Program or purchase the Business Starter Kit (BSK) for \$449.

You qualify to receive FastStart Way 7-Level bonuses in August through October. You need to be a Qualified Silver Director or above in October to continue to receive bonuses each month thereafter. Additionally, you need a 100 CV AutoShip and a Communication Program subscription every month.

You qualify to receive FastStart Way 7-Level bonuses the week the qualifications are met and the balance of that month, plus two (2) full months thereafter. You must be Silver Director by the end of the second full month to receive bonuses the following month. Additionally, you need a 100 CV AutoShip and a Communication Program subscription every month.

THE NEW FASTSTART WAY Q&As

AutoShip Program, Communication Program (CP)

Q: Can I count my Custom Essentials® in my AutoShip towards my 100 CV?

A: Yes. The computer looks at the prior month to determine if you met the AutoShip 100 CV requirement.

If your PrivaTest® Results and new Custom Essentials are available seven (7) days prior to your AutoShip shipping date, they will be held and placed into that AutoShip. If your PrivaTest Results and new Custom Essentials are available eight (8) to fourteen (14) days before your AutoShip shipping date, they will be shipped immediately and your AutoShip will be shipped without them on its established shipping date. If your PrivaTest Results and new Custom Essentials are available more than fourteen (14) days before your AutoShip shipping date, they will be shipped immediately and your Custom Essentials will also be included in your next AutoShip.

The 50 CV on your Custom Essentials counts toward your AutoShip 100 CV requirement only when the product is shipped.

Q: Are multiple AutoShips on the same account combined to meet the AutoShip 100 CV requirement?

A: Yes.

Q: Will I still be AutoShip 100 CV qualified if I receive my Custom Essentials free as a result of a promotional program such as “Refer A Friend”?

A: Yes, but the 50 CV associated with Custom Essentials does not count towards month end qualification.

Q: Do I have to be on the Communications Program for August?

A: Yes if you want to qualify to receive your FastStart 1-Level and FastStart 7-Level Bonuses.

Q: Is the Communication Program needed to receive a monthly commission check?

A: No, you only need a Communication Program subscription to receive FastStart 1 and 7-Level Bonuses.

Q: I’m already a Marketer. How do I order my Communication Program, AutoShip 100 CV, and/or Business Starter Kit \$449 to receive my FastStart 7-Level Bonuses? (See previous page)

A: Go to www.uixonline.com and log in.

Business Starter Kit:

1. Select the “Ordering” menu.
2. Select “Search the UIX Store.”
3. In “Search for:” enter 99020 and Select, “Go.”
4. Order the “Business Starter Kit” \$449.
5. Complete the order.

Order AutoShip:

1. Then in the same back office on the left menu click on “Manage AutoShips.”
2. Select, “Create a new AutoShip,” or “Edit Existing AutoShip,” if you need to upgrade your AutoShip to 100 CV.

Order Communication Program:

1. Select, “Manage Settings,” on the left menu.
2. Select, “Communications Program Settings” and enroll in the \$19.⁹⁵ Communication Program.

The Trump Leads Program

Simply be a Gold Director (or above) and subscribe to the Communications Program in a current month, and the next month you are automatically qualified to receive Free Leads. The Trump Leads Program has been simplified.

The 4 month qualification program is discontinued, now only one month to qualify:

Three (3) levels qualify for leads:

- Gold Directors get 1 lead
- Platinum Directors get 2 leads
- Diamond Directors get 3 leads
- Add 1 lead for Custom Essentials in your AutoShip
- Add 1 lead for Marketers who previously purchased the iMail Program

Q: Do I have to send in the Lead Qualification Form to the company to start my qualification?

A: No, it is no longer required. Once you reach Gold Director (or above) you are eligible to receive leads the next month.

Q: If I achieved Gold Director last month (July), do I qualify to receive leads in August?

A: Yes.

Q: If I reached Silver Director and qualified in the old Leads Program (4 month qualification), do I receive leads for August?

A: Yes, you are grandfathered to receive leads for August and September. You just need to be a Silver Director (or above) in August, and subscribe to the Communication Program.

- Each month thereafter, simply be a Gold Director (or above) and subscribe to the Communication Program to receive leads the next month.

Q: What leg structure does a QuickSilver create?

A: A QuickSilver counts towards a Bronze Leg until it achieves a higher rank.

What are the qualification changes to receive my monthly commission check?

- Custom Essentials is not required in an AutoShip or for Pin Level Director qualifications.
- AutoShip is not required to receive **monthly** commission checks, based on Director levels of achievement (Director, Bronze, Silver, Gold, Platinum, Diamond, etc.)
- Communication Program is optional.
- Platinums can now count 4 levels of CGV to qualify for Platinum Director (increased from 3 levels).
- No longer required to be a Silver or Gold Director the month before achieving Platinum Director.

Once you achieve Platinum in any month, you are a Platinum.

Silver Director and QuickSilver Director Clarification:

- Only QuickSilver (FastStart Way Purchasers) and qualified Silver Directors (3 Director legs with 600 CGV) will be recognized going forward.
- Silver Directors (not QuickSilver Directors) count towards Platinum leg structure qualifications.

Other Enhancements:

PrivaTest®, Custom Essentials®, and Prime Essentials®

Q: As a FastStart Way Marketer, can I buy more PrivaTest Kits in my primary account at a discount?

A: Yes, PrivaTest Kits for family members in your Primary Account are offered at \$89.⁹⁵, a savings of \$50 each. Follow the PrivaTest Coupon instructions inside the Business Starter Kit.

Q: As a non-FastStart Way Marketer, can I buy PrivaTest Kits?

A: Yes, you can order your first PrivaTest Kit at \$139.⁹⁵. The \$50 bonus is paid to the Enroller.

Q: What are the prices for all new Marketers and customers for New Custom Essentials (CE) and Prime Essentials (PE) starting August 12th?

A: The pricing for new Marketers and customers is as follows:

Custom Essentials:

- Marketers - \$59.⁹⁵
- Preferred Customers - \$64.⁹⁵
- Retail Customers - \$69.⁹⁵

All new Custom Essentials users to receive 50 CV, 83% of the wholesale price.

Prime Essentials:

- Marketers - \$44.⁹⁵
- Preferred Customers - \$49.⁹⁵
- Retail Customers - \$55.⁹⁵

All new Prime Essentials users to receive 36 CV, 80% of the wholesale price.

Q: What is the new Custom Essentials price for new and existing Marketers?

A: The existing Marketers (at their option) can call to change their price point to \$59.⁹⁵ to receive the 50 CV. New Marketers pay \$59.⁹⁵ with 50 CV. Simply call Customer Care at 800-768-7667.

Q: How does the computer know that a FastStart Way Marketer is entitled to purchase their PrivaTest Kits at \$89.⁹⁵?

A: Through August 31st, all Marketers will receive their PrivaTest for \$89.⁹⁵. After August 31st, a Marketer who does not choose the FastStart Way Program or \$449 BSK, will be charged \$139.⁹⁵ for their first PrivaTest.

Q: Can I still purchase extra PrivaTest Kits from the Company?

A: Yes, you can enroll Customers online and through Customer Care.

You can continue to purchase PrivaTest Kit 5 packs (\$20 each for a total of \$100) for your Customers. You will be reimbursed \$20 plus receive a \$50 bonus for each activated kit.

Q: Is the price the same for customers?

A: Yes, Customers pay \$139.⁹⁵ for their PrivaTest Kit. The Enroller receives a \$50 bonus.

Q: What will happen with the Trump Business Leadership Programs?

A: Leadership programs are discontinued as of August 12th.

- Marketers with BSKs can sell them for \$449 and keep the entire \$225 FastStart 7-Level Bonuses.
- Just give your new Marketer the Dual/Disc Booklets 10-Pak with each BSK.
- Marketers will automatically receive the two (2) \$50 PrivaTest savings when they purchase the PrivaTest online or through customer care when you follow the instructions associated with the next question.

Q: How does a New Marketer receive all the FastStart Way benefits when a Business Starter Kit (BSK) is purchased in person and NOT from the company?

A: First, choose a Scenario:

Scenario 1: If a Marketer Kit (membership) was previously purchased, but the New Marketer needs AutoShip 100 CV and/or the Communication Program, then the new Marketer needs to follow **Scenario 1** below.

Scenario 2: If NO \$48 Marketer Kit, AutoShip, or Communication Program has been ordered, follow **Scenario 2** on the following page.

Note: In the case of both Scenario 1 & 2, for the remainder of the month in which the Marketer purchased a BSK from an existing Marketer, they do not need to have an AutoShip 100 CV to qualify for the FastStart 7-Level Bonuses. They qualify automatically. However, they will need an AutoShip 100 CV the first full month and from that point forward, to qualify

Scenario 1:

If a Marketer Kit was previously purchased, but the New Marketer needs AutoShip 100 CV and/or the Communication Program, then the new Marketer needs to follow these steps:

A: How to set up your AutoShip 100 CV:

First, go to www.uixonline.com and login.

1. Once logged in, select "Manage AutoShip."
2. Select, "Create a New AutoShip."
3. Complete, "Give the AutoShip a Name."
4. Select an AutoShip Date. Choose a date within thirty (30) days from the Marketer Kit enrollment date, or the date you purchased a Business Starter Kit from your Sponsor.
5. Continue the process, and add your products.

B: How to set up your Communication Program:

First, go to www.uixonline.com and login.

4. Complete the rest of the process and make sure you select, "Save Your Information."

Scenario 2:

If NO \$48 Marketer Kit, AutoShip 100 CV, or Communication Program has been ordered, follow these steps.

The Enroller or New Marketer needs to go to the Enroller's personalized web site: www.trumpnetwork.com/enrollername.

1. Select "I want to Start My Business." button on the homepage.
2. Select "Continue."
3. Choose "Marketer Kit \$48."
4. Under "Marketer Kit," select "Add to Cart."
5. **DO NOT** add "AutoShip 100 CV Plan," to the Cart. (see #8 below)
6. Under "Communication Program," select "Add to Cart."
7. Proceed to checkout.
8. To establish an AutoShip 100 CV Plan, the **Enrollee** simply goes to www.uixonline.com> Select Manage AutoShip> Create New AutoShip> Name your AutoShip and pick a date for shipment in the following month within 30 days of your Membership date> Select Continue> Confirm Address> Confirm Credit Card> Select Products that will generate 100 CV in your AutoShip> Select "Add Selected Items to AutoShip"> Select "Save Your Information".

The **"Enroller"** needs to activate the new FastStart Way Marketer on the "Enrollee FastStart Way" report—located at uixonline.com> My Account Overview> View Reports> Enrollee FastStart Way> Select "Purchased" next to the person's name> Click "Save Your Information".

The new FastStart Way Marketer will not receive any weekly bonuses if this is not done. Note: The Company will automatically add an additional two (2) Free months to the new FastStart Way Marketers' Communication Program subscription.

Important Notice: The New Marketer will NOT receive FastStart 7-Level Bonuses unless the Enroller checks the appropriate box at the Enroller's back office. Enrollers' follow these simple steps:

Q: Is the Company going to create a conversion kit with Silhouette Staples Lemon Bars, Trump Network Dual/Disc Booklet 10-pak, and PrivaTest \$50 Off Coupon?

A: No. When a Business Starter Kit is purchased from a Marketer, the \$50 Off PrivaTest Coupon is automatically applied to PrivaTest orders when the Enroller follows the instructions titled **"Important Notice"** above. Invite the New Marketer to try Silhouette Staples Lemon Bars at their convenience. You should order enough "Trump Network Dual/Disc Booklets" 10-paks for each Business Starter Kit you have on hand.

Q: Someone purchases a Business Starter Kit (BSK) from me. I activate the new FastStart Way Marketer on the “Enrollee FastStart Way” report located at uixonline.com> My Account Overview> View Reports> Enrollee FastStart Way> Select “Purchased” next to the person’s name> Click “Save Your Information”. Do they count as a Director Leg?

A: Yes.

Paperwork

If enrollment is done online, it is no longer required to send the Membership Agreement to the company.

If enrollment is done through the Call Center, the new Marketer still needs to complete a Membership Agreement.

Wholesale Buyer Program

This program is discontinued as of August 12th, but anyone who is currently in the program will be grandfathered.
